ESG compliance: Europe vs. the United States

Europe: Regulation leads the way

The EU is setting the global pace on ESG with mandatory frameworks:

- CSRD (Corporate Sustainability Reporting Directive): Expands ESG reporting to over 50,000 companies by 2026
- EU Taxonomy: Defines what counts as a sustainable economic activity

MSPs serving EU-based clients must show ESG alignment — including emissions tracking, supply chain transparency, and governance readiness.

United States: Market forces in motion

While the U.S. lacks sweeping legislation, momentum is growing:

- **SEC Climate Disclosure (proposed)**: Will require public companies to disclose climate risks
- Investor expectations: ESG investments reached \$8.4 trillion in 2022 and growing

U.S.-based MSPs may not yet face legal mandates, but enterprise clients increasingly require ESG-readiness in supplier assessments.
